§4-6-1. General.

6-1.1. Scope. - - This rule provides for the fees that shall apply to the practice of chiropractic in the State of West Virginia.

6-1.2. Authority. - - W. Va. Code 30-16-5.

6-1.3. Filing Date. - - July 25, 2013.

6-1.4. Effective Date. - - July 1, 2014.

§4-6-2. Fees.

6-2.1. The annual renewal fee for chiropractors practicing in West Virginia is \$300, out of state or retired chiropractors is \$150.

6-2.2. If the license renewal requirements are postmarked after July 1, there is a \$200 late fee.

6-2.3. If the license renewal requirements are postmarked after July 31, there is an additional \$200 reinstatement fee.

6-2.4. The fee for each application for approval for articles of incorporation is \$150 per request. The initial filing fee for a chiropractic corporation or a professional limited liability company is \$150 and an annual renewal fee of \$150.

6-2.5. The examination fee is \$150 per applicant and a fee of \$50 per applicant for reexamination.

6-2.6. The initial licensing fee is \$50 per licensee.

6-2.7. The fee for requests for continuing education courses is \$100 per course.

6-2.8. The application fee for preceptorship approval is \$50 per student.

6-2.9. There is a fee of \$250 per request for address listings.
